SRS's primary program provides transportation to Weld County seniors free of charge, regardless of income. This is accomplished with the use of volunteers who drive their own vehicles, though we own and utilize one minivan for non-medical appointments in the Greeley-Evans area. We currently have 887 clients on our rolls and transported 321 unduplicated clients for 10,899 one-way rides, utilizing 147 active volunteers who gave a total of 6,572 hours of service, in 2016.

SRS's Caregiver Respite Program provides volunteer companionship for a few hours per week to Weld seniors free of charge, regardless of income, allowing family caregivers to take care of their own health needs without leaving their patients unattended.
