An Update on Rules and Regulations

Medicare covers home health services for individuals who are confined to their homes and in need of skilled nursing care on an intermittent basis or physical therapy,

speech/language pathology, or where they have a continuing need for occupational therapy. To qualify for coverage, a patient must be under the care of a physician who certifies the need for care and that the individual is confined to his home.

There has been a recent change in the law that will encourage greater involvement of the physician in a patient's home health care services. On January 1, 2011 the Patient Protection Affordable Care Act issued a final regulation whereby Medicare will pay for home health services only when a patient has had a Face-TO FACE encounter with the physician or certain non-physician practitioners working with the physician, that certifies that home health plan of care in the 90 pays prior to or 30 pays of the start of services.

This face-to face encounter must be:

- Made by the physician (or non-physician practitioner) responsible for certifying home health.
- Related to the primary reason for which the patient requires home health services
- Made within 90 days prior to, or within 30 days of, the start of home health.

Documentation of the certification of a face-to-face encounter must include:

- Date of encounter
- Indication that the encounter was related to the primary reason for home health
- An explanation of how the clinical findings of the encounter support the need for skilled nursing or therapy services
- An explanation of why the clinical findings of the encounter support that the patient is homebound
- Your signature and date of that signature

This requirement is quite complex so please ask your doctor to assist you if there is a need for home health services.

I hope the Senior Resource Services staff are assisting you to remain independent and you are enjoying the companionship of our devoted Volunteers. If we may answer any questions that you may have, please call our office.

PROVIDING SERVICE TO OUR SENIORS

Senior Resource Services is growing at an unprecedented pace. Never in our wildest imagination did the DeeAnn Groves believe that in three and a half years we would be serving 221 clients and providing free services covering all of Weld County.

In 2007 we opened our doors at 1802 16th Street in Greeley with 1 volunteer and 1 client, a part-time Executive Director and a part-time office person. With the belief of the community and financial support from generous foundations we have listened to the Seniors in Weld County and assisted them to remain independent for as long as possible. Of course none of this is possible without the caring volunteers who lovingly dedicate a few hours to enhance the lives of those they help.

Our most popular program is the free transportation to medical appointments, hair appointments, grocery shopping and special events. In the last few months we have provided more "Caregiver Time Out services by just being a special friend and having a volunteer visit with our Senior in their homes.
